Farm Boards' stipend and per diem payments fluctuates annually depending on the Navajo Nation Council decisions and the availability of funds. Compared to the Eastern Navajo Land Board and Grazing Officials, the Farm Boards' stipends and per diem budget is not set as a statute, thereby an annual budget projection is a challenge for the Department of Agriculture. Stipend and per diem payments is based on the annual program budget allocation, thus sets the compensation at the lowest rates. The Budget and Finance Committee recommends concerted effort to resolve the inequitable stipends and per diem payments by setting standard rates.
